

REQUEST FOR PROPOSALS

TOWNSHIP OF SALISBURY, LEHIGH COUNTY, PA

(revised 2/7/11)

The Township of Salisbury will accept sealed proposals for the installation of a Fire Alarm system at the Eastern Salisbury Fire and Rescue Building, 1000 E. Emmaus Avenue, Allentown PA, 18103 in accordance with Drawings E-1, dated August 16, 2010, prepared by Liberty Engineering. The work shall include, but is not limited to, installing owner-supplied equipment and all other required incidental items for a fully operational fire alarm system.

Sealed Proposals will be received until 10:00 a.m. (prevailing time) on **Tuesday, February 22, 2011**, at the office of the Township Manager, Salisbury Township, 2900 S. Pike Avenue, Allentown, PA 18103 at which time they will be publicly opened. All Proposals should be sealed, marked and addressed as follows: Proposal For Installation of Fire Alarm System, Salisbury Township, 2900 South Pike Avenue Allentown, PA 18103.

The Township reserves the right to reject any or all quotations/proposals for any reasons.

PROJECT LOCATION, SCOPE OF WORK AND SPECIAL CONDITIONS

PROJECT LOCATION

The work covered by this Request For Proposals (RFP) will be performed at the Eastern Salisbury Fire and Rescue Station, 1000 E. Emmaus Avenue, Salisbury Township, Lehigh County, Pennsylvania.

SCOPE OF WORK

The Contractor shall install equipment supplied by the Township (Owner of the property referenced under Project Location) as described in the list of equipment (See Attachment "A") and shown in the Drawing E-1 dated August 16, 2010 prepared by Liberty Engineering (See Attachment "B").

The Contractor shall supply all labor tools and other incidental items/equipment not shown on the Drawing, if necessary, to properly install the equipment furnished by the Township to ensure a fully *operational* fire alarm system. All programming of the system shall be the responsibility of the Contractor.

Any apparatus, material and labor not hereinafter specifically mentioned or shown on the Drawing, which may be necessary to complete or perfect any portion of the Work in a substantial manner and in compliance with the requirements implied or intended in the Specifications, shall be furnished by the Contractor without additional compensation. This shall include all materials, devices and methods peculiar to the apparatus or system furnished and installed by the Contractor.

GENERAL CONTRACTOR'S RESPONSIBILITIES

The Contractor shall be responsible for the coordination of all work on the project and assure the proper installation and scheduling of all work and subcontractors' work (if applicable).

SPECIAL CONDITIONS

The Fire Alarm System installation will involve detailed coordination with the Township and the Volunteer Fire Department to maintain continuous operation of the Eastern Salisbury Fire and Rescue Station.

CONSTRUCTION SCHEDULE

The Contractor will be required to prepare a detailed construction schedule outlining anticipated dates for the start and completion of each phase of the project.

The Contractor shall include dates for various stages of the installation as well as the work task involved. The installation schedule shall consider maintaining service. The schedule shall also indicate any operations by the Contractor, which may require a complete system shut-down.

The Contractor's schedule must be submitted to the Township's Engineer for review and approval ten (10) working days prior to the beginning of any construction operations.

QUALIFICATIONS OF CONTRACTORS

To demonstrate qualifications to perform the Work, each Contractor must be prepared to submit detailed information of past similar work completed in the last five (5) years.

EXAMINATION OF SITE

It is the responsibility of each Contractor, prior to submitting a Proposal, to (a) examine the Drawing thoroughly, (b) visit the site to become familiar with local conditions which may affect cost, progress, performance or furnishing of the Work, (c) consider federal, state and local laws and regulations which may affect the cost, progress, performance or furnishing of the Work, (d) notify Engineer of all conflicts, errors or discrepancies in the Drawings.

On request in advance, the Township will provide each Proposer access to the site to conduct such explorations and tests as each Proposer deems necessary for submission of a Proposal. The site visit shall be coordinated with the personnel of the fire department as designated by the Fire Chief.

CONTRACT TIME

Contractor shall state the number of days the intended work will be completed.

COST PROPOSAL

The Proposal shall indicate the number of hours and hourly rate the Contractor will charge for the completion of the work and shall include a not to exceed amount. A professional fee schedule shall be attached to the Proposal.

PROPOSAL FORM

The Proposals are to be submitted on company letterhead signed by the owner or official designated to bind the Contractor to carry out the required work.

SUBMISSION OF PROPOSALS

Proposals shall be submitted at the time and place indicated in the Request for Proposals and shall be enclosed in an opaque sealed envelope, marked with the Project Title and name and address of the Contractor, and accompanied by other required documents. If the Proposal is sent through the mail or other delivery system, the sealed envelope shall be enclosed in a separate envelope with the notation "Proposal For Installation of Fire Alarm System, Salisbury Township, 2900 South Pike Avenue Allentown, PA 18103" on the face of it.

INSURANCE REQUIREMENTS

Contractor shall, at its expense, procure and maintain for the duration of the Agreement insurance against claims for injuries to persons or damages to property which may arise from or

in connection with the performance of the Work by the Contractor, its agents, representatives, employees or subcontractors. Contractor shall also require all of its subcontractors to procure and maintain the same insurance for the duration of the Agreement. Such insurance shall meet at least the following minimum levels of coverage:

The limits of liability for the insurance shall provide for not less than the following amounts or greater where required by Laws and Regulations:

Worker's Compensation, etc.

Statutory Minimum Limit

Comprehensive General Liability

1. Bodily Injury liability: (including completed operations and products liability)

2. Property Damage liability insurance will provide Explosion, Collapse and Underground coverage, where applicable.

\$1,000,000 Each Occurrence or a combined single limit of

A Certificate of Insurance shall be submitted to the Township on an Acord Form with the Township and Liberty Engineering, Inc. listed as additional insured for claims arising out of the performance of the Work.

OPENING OF PROPOSALS

Proposals will be opened on the date affixed for the opening in the Notice of the RFP.

AWARD OF CONTRACT

Owner reserves the right to reject any and all Proposals, to waive any and all informalities not involving price, time or changes in the Work and to negotiate contract terms with the Successful Proposer, and the right to disregard all nonconforming, nonresponsive, unbalanced or conditional Proposals. Also, Owner reserves the right to reject the Proposals of any Proposer if Owner believes that it would not be in the best interest of the Project to make an award to that Proposer, whether because the Proposal is not responsive or the Proposer is unqualified or of doubtful financial ability or fails to meet any other pertinent standard or criteria established by Owner.

In evaluating Proposals, Owner will consider the qualifications of the Proposer, whether or not the Proposals comply with the prescribed requirements.

Owner may conduct such investigations as Owner deems necessary to assist in the evaluation of any Proposals and to establish the responsibility, qualifications and financial ability of Proposers, proposed Subcontractors, Suppliers and other persons and organizations to perform and furnish the Work in accordance with the Contract Documents to Owner's satisfaction within the prescribed time.

If the Contract is to be awarded, it will be awarded to the lowest responsible Proposer whose evaluation by Owner indicates to Owner that the award will be in the best interests of the Project.

If the contract is to be awarded, Owner will provide the Successful Proposer a Notice of Award within forty-five (45) days after the day of the Proposal opening.

SIGNING OF AGREEMENT

When Owner gives a Notice of Award to the Successful Proposer, it will be accompanied by the required number of unsigned counterparts of the Agreement with all other written Contract Documents attached. Within ten (10) days thereafter, Contractor shall sign and deliver the required number of counterparts of the Agreement and attached documents to the Owner with the required insurance. Within seven (7) days of approval of these documents, Owner shall deliver one (1) fully signed counterpart to the Contractor. Each counterpart is to be accompanied by a complete set of the Drawings and appropriate identification.

PROJECT SCHEDULE - The tentative project schedule is as follows:

INSTALLATION SCHEDULE - The Contractor will be required to provide a tentative installation schedule for the complete project to the Owner for approval. Any changes resulting from the Owner's approval shall be made and a final project schedule submitted.

PERMITS - The Contractor will be required to obtain any and all permits, licenses, inspection fees or other privileges necessary to complete or perform work within the area except as follows:

- A. All fees required for permits by Salisbury Township will be waived. It will be the responsibility of the contractor to still obtain permit for the work.

Please Note: Drawing E-1, dated August 16, 2010 has been reviewed and approved by Code Master, the Township Inspector.

AGREEMENT

THIS AGREEMENT is dated as of the _____ day of _____, 20____, by and between the TOWNSHIP of SALISBURY, 2900 South Pike Avenue, Allentown, PA 18103 (hereinafter called Owner) and _____ (hereinafter called Contractor). Owner and Contractor, in consideration of the mutual covenants hereinafter set forth, agree as follows:

Article 1. **WORK**

Contractor shall complete all Work as specified or indicated in the Contract Documents and Drawing E-1, dated August 16, 2010. The Work is generally described as follows:

EASTERN SALISBURY FIRE AND RESCUE STATION
FIRE ALARM SYSTEM

Article 2. **ENGINEER**

The Project has been designed by Liberty Engineering, Inc., 7535 Windsor Drive, Suite B-203, Allentown, PA 18195 who is hereinafter called Engineer and who is to act as Owner's representative, if requested, and assume all duties and responsibilities and have the rights and authority assigned to Engineer in the Contract Documents in connection with completion of the Work in accordance with the Contract Documents.

Article 3. **CONTRACT TIME**

All Work will be completed within 30 calendar days from the date when the Contract Time commences.

Article 4. **CONTRACT PRICE**

Owner shall pay Contractor for completion of the Work in accordance with the Contract Documents and the Proposal as measured and approved by the Engineer.

Article 5. **PAYMENT PROCEDURES**

Contractor shall submit an Application for Payment. Application for Payment will be processed by Engineer.

5.1 **Final Payment**

Upon final completion and acceptance of the Work, Owner shall pay the amount of the Contract Price as recommended by the Engineer.

IN WITNESS WHEREOF, Owner and Contractor have signed this Agreement in triplicate. One counterpart each has been delivered to Owner, Contractor and Engineer. All portions of the

Contract Documents have been signed or identified by Owner and Contractor or by the Engineer on their behalf.
