- Discussion on compact fluorescent light bulbs. There is a lot of advocacy for the use of CFL bulbs in the environmental community for both energy efficiency and also monetary savings. The question that I would like to address is “how are we to dispose of these new bulbs”? Typically throwing them in the waste stream is not the appropriate thing to do. I also called Home Depot to learn that the spiral CFL bulbs can be taken to the Home Depot where they have specialized bags to place the spent bulb then deposit into a recycling container specifically for that type of bulb. The area of the container is located near the Specialty Section. The following local companies are also involved with reclaiming and recycling CFL bulbs:
